A. General Information

Association for Individual Development (AID) is soliciting proposals for Architectural and Engineering Services for the new construction of a community mental health center in Elgin, Illinois. Celebrating 62 years of providing customized, consumer-focused programs and services in an equitable, inclusive manner, the Association for Individual Development (AID) works with individuals with developmental, intellectual, physical and/or mental health challenges, those who have suffered a trauma, those experiencing immediate and/or chronic crises and those at risk to overcome personal, behavioral, societal and environmental barriers to achieve recovery, independence, self-reliance and to live the lives they choose. Operating in Kane, Kendall, DeKalb, DuPage, Will, McHenry and suburban Cook County communities, AID is accredited by the Commission on Accreditation of Rehabilitation Facilities (CARF) and the American Association of Suicidology (AAS). In FY 2022, AID served 5700 people in client-centric, community-based programs.

B. Project Description

The subject property is located on a 16-acre parcel of land owned by AID. The site is located at 695 South State Street and is part of a larger redevelopment initiative by AID that includes a Permanent Supportive Housing development and a Low-Income Housing Tax Credit development on the same site. AID proposes to use 1.81 acres of this parcel in Elgin for the AID Wildwood Community Mental Health Center (the CMH). The proposed Community Mental Health Center and social service center will be a 2-story building that will include Community Mental Health Center space, Employment Services for people with disabilities, AID Finance and Resource Development departments, as well as co-location space for Genoa Healthcare, a closed-door pharmacy. The on-site pharmacy will provide direct access to a pharmacy team that is dedicated to AID staff and consumers and greatly improves efficacy of treatment and medication adherence for persons with behavioral health diagnoses. The building will also have

available drop-down space for other healthcare and social service providers and meeting space for book clubs, 12-step groups, and other community events.

AID is seeking an architecture firm to fully design this new construction, stand-alone structure that will be approximately 20,000 sf with a foot print of approximately 10,000 sf on a lot size approximately 2 acres. AID seeks about 70 parking spaces, site landscaping, walkways and lighting.

The building to include a reception area and lobby, offices, a community room, library, computer lab, closed door pharmacy, nursing office, and classrooms. The bulk of the space will be used for office space for clinicians to meet with clients. The design work will include all elements of new construction including planning and design for site work, including grading, roads and walkways, parking, utilities, and landscaping. The project includes all design elements of a new construction 2-story building including facility construction (concrete, masonry, metals, wood/framing, insulation, doors/windows, finishes, specialties, equipment) and facility services (fire suppression, plumbing, heating/cooling, electrical).

The architect will need to collaborate with our pharmacy partner on the design and layout of the pharmacy.
